Delaware State Police


Detective Timothy Kerstetter is a 23-year veteran of the Delaware State Police with a vast amount of law enforcement experience. With extensive training and experience, the majority of Det. Kerstetter's career has focused on investigations and law enforcement instruction.

Det. Kerstetter served as an investigator in a variety of special investigations units. Most notably, Det. Kerstetter served as Delaware's first police officer to serve in the FBI's Joint Terrorism Task Force. After serving with distinction in the JTTF for nine years, and as bomb technician on the Explosive Ordnance Disposal team for seven years, he established himself as Delaware's ambassador for Homeland Security. Det. Kerstetter has been recognized for his unique ability to analyze macro-level national security matters and provide instruction on a localized level, relevant to Delaware First Responders and citizens. Numerous First Responders, federal law enforcement and intelligence agencies along with countless professional organizations have embraced his successful "Hometown Security" doctrine.

Det. Kerstetter currently serves as the Terrorism Liaison Officer at the Delaware Information & Analysis Center, the state's Homeland Security-based fusion center. Det. Kerstetter is a certified Master Instructor with the Delaware Council on Police Training. He has designed and implemented the highly sought after annual training initiative entitled the Hometown Security Conference, which provides professional training to First Responders throughout the Mid-Atlantic region. Furthermore, Det. Kerstetter has developed the Violent Intruder Preparedness & Response (VIPR) training program to improve citizens' readiness against random acts of mass violence. He regularly provides executive briefings and line-level instruction on emerging threats to include topics such as Active Shooter Events, Improvised Explosive Devices, suspicious behaviors and reporting, and tradecraft of Homegrown Violent Extremists.

Det. Kerstetter is a member of several professional associations and has received commendations from the Director of the FBI, Delaware's Secretary of Safety and Homeland Security and the Superintendent of the Delaware State Police.



# Chief Procurement Officer Government Support Services (GSS) State of Delaware


Dean serves as the Chief Procurement Officer for the State of Delaware and is the director for Government Support Services (GSS). In this role, Dean is responsible for the administrative oversight of the following divisions:

- Office of Fleet Services which maintains and dispatches over 2,400 vehicles
- Central Contracting Unit which manages over \$250 million in contracts
- State Mail operations that delivers three million pieces of USPS metered mail and one million pieces of interdepartmental mail
- Surplus Property Program that dispenses all surplus state property with the exception of real estate
- Federal Food Commodities program which maintains a warehouse responsible for distributing 20 percent of school lunch commodities and services six specialty food programs
- Printing & Publishing operation that provides \$1.5 million worth of print services to state agencies annually
- Payroll Human Resources Statewide Technology (PHRST) operation that is responsible for a \$76 million biweekly payroll

In addition to these responsibilities, by virtue of his position, Dean sits on the Commission for Statewide Contracts to Support Employment for Individuals with Disabilities. This commission is responsible for establishing a list of goods and services to be provided to the state and local governments manufactured by this constituency group. Dean is a member of the Governor's Supplier Diversion Council and chairs the Procurement Committee for executive agencies in the State of Delaware. Dean previously served on the NASPO board of directors and is a past president of NASPO.

Dean holds a Master of Science in Human Resource Management and a Master of Science in Public Administration. He is also a certified CPPO.


