Minutes of Thursday, September 26, 2014

The Third Quarter meeting of the Delaware Public Purchasing Association (DPPA) for 2014 was hosted by the Town of Bethany Beach.

Opening of the Meeting - Clifton

Reading of the Minutes

Chapter Liaison – Clifton (Chairperson)

Cliff was unable to attend the Region II Conference Call. Sussanne was able to attend. There is a newsletter on the NIGP website regarding the Forum. There has been nothing but good reviews regarding the Forum. The Region Reps will now be called Ambassadors. There will be 2 Ambassadors for every Region.

Ohio is now a new chapter. Region II is losing NJ, but gaining VA. Region II will now be called Area 2. VA hosts 2 conferences every year. Delaware is set to host the Regional in 2016. Lisa stated that the Town of Bethany will have a new hotel in 2017. George and Maureen are looking for feedback about Virginia coming into the Region.

Ambassadors are supposed to visit every chapter every year. Leadership Symposium scheduled 1/29 – 31 for \$299. Chapter award specifications are being redesigned. MD

has held 18 educational classes. They are hosting a reverse trade show 11/20. DC has a website www.NIGPMWC.org. South Jersey held a fishing trip.

Cliff stated that it was announced at the Forum that VA was coming into Region II. VA has 2 conferences a year and they do not want to rotate. Sussanne suggests that the presidents talk to the VA people before changes come into effect next year. George Nader suggested Delaware do a Reverse Trade Show to make up for negative effect of monies with VA coming on board.

There was a lot of discussion about hosts NIGP classes. Cliff stated that hosting the CPPB/ CPPO review would be best.

Juanita asked if it would be an issue if vendors who service small communities be at a disadvantage competing with big national businesses.

There was discussion on having member access only sections on the website. Bruce stated that if we have sections from our various municipalities, then it will become a networking hub. Mike stated that NASPO and NIGP are doing essentially the same thing. He stated that he remembers having membership in both organizations. Cliff asked Bruce about the upcoming Vendor Days and how DPPA can get involved.
